Dear Friends of AISCD,

In view of our National's part of Indian team participation in World Deaf Chess Olympiad, Asia Pacific Deaf Chess Championships and other International Competitions in the past which has proved our strength, speed and success by our highly skilled youngsters and as a policy matter of the All India Sports Council of the Deaf to organize such National Events in as many as various disciplines of Sports and Games relying on its Annual Sports Calendar, the State affiliated Units coming forward, the Karnataka Sports Federation of the Deaf has agreed to host the XXV National Chess Championship of the Deaf at the Nithyananda Kalyana Mantapa, 55/B, Next to Sterling theatre, 1st Stage, Vishweshwara nagar, Mysuru, Karnataka State on January 05 to 09, 2025 with the Mysore District Association of the Deaf as the Co-host.

Each State Team will consist of 15 (6 Men, 3 Junior Boys U-18, 3 Women, 3 Junior Girls U-18 players and 2 coach-cum-managers i.e. one male & one female) with total not to exceed 17 participants per State. The championship will be played as per Rules of the Swiss System and will simultaneously decide champion – Individual as well as State on the strength of points scored.



Section – I : Organisation

1. In view of our National's part of Indian team participation in World Deaf Chess Olympiad, Asia Pacific Deaf Chess Championships and other International Competitions in the past which has proved our strength, speed and success by our highly skilled youngsters and as a policy matter of the All India Sports Council of the Deaf to organize such National Events in as many as various disciplines of Sports and Games relying on its Annual Sports Calendar, the State affiliated Units coming forward, the Karnataka Sports Federation of the Deaf, Bengaluru has agreed to host the XXV National Chess Championship of the Deaf at Nithyananda Kayana Mantapa, Vishweshwara nagar, Mysuru, Karnataka State on January 05 to 09, 2025.

Section – II : Eligibility for Participation

1. Only amateur Deaf Chess Players entered by affiliated State Organisations of the All India Sports Council of the Deaf are eligible for participation in the Championship.

2. Participation in the Championship is restricted to persons who must be deaf, defined as a hearing loss of at least 55dB PTA in the better ear (3-tone frequency average at 500, 1000 and 2000 Hertz, air conduction ISO 1969 Standard).
3. Participants must be well versed with rules of the Games of Chess.
4. Player can represent only the State where he/she is employed/studying/normally residing.
5. Player, who has participated any discipline of Sports & Games in Tournament/Championship organized by Unauthorised Organisation, shall not be eligible to participate in the Championship.

Section – III: Classification of Age Groups

1. The Classification of age groups shall be recorded as on 31-01-2025
2. The age groups shall be given below:
Men & Women: Above 18 Years (born on or before 31-01-2007)
Junior Boys & Girls: Below 18 Years (born on or after 01-02-2007)
3. Participation of competitors in Junior Groups in the Championship is subject to the submission of Certificate of Birth issued by Village/Municipal/Corporation/Aadhaar (original or attested copy) along with the Final Entry Form.

Section – IV: Identification

1. Each Player must present a letter of Identification from the Organisation sending him/her to the Championship.
2. Identity cards carrying his attested photo by All India Sports Council of the Deaf must be produced by him/ her on demand. No player will be allowed to participate in the Championship without the Identity Card.

Section – V: Programme and Entry

2. Each State Team will consist of 15 (6 Men, 3 Junior Boys U-18, 3 Women, 3 Junior Girls U-18 players and 2 coach-cum-managers i.e. one male & one female) with total not to exceed 17 participants per State.
3. Confirmation of participation should reach the Organisers- Mr. Darshan Kshirsagar, AISCD Assistant Technical Director – Chess and the hosts latest by **Saturday 30th November 2024** along with Entry Form by E-mail.
4. No changes or additional entries will be entertained after the due date.

Section - VI: Prohibitions

Strict measures against indiscipline during the course of Championship, has been taken suitable measures to be implemented in view of large disputes / complaints rose in the past. Rules are to be operated in lines with the World Deaf Chess Championships organized by International Committee of Silent Chess. The following items has been prohibited / banned in order to improve smooth functioning of the Championship.

1. Use of Hearing Aids and Mobiles.
2. Sign Language.
3. Smoking.
4. Serving Tea and Soft Drinks.
5. Camera shooting with Flashing.

Section - VII: System of Play & Rules and Regulations.

The tournament will be played under FIDE's laws of Chess and the Swiss system. Totally nine rounds or less rounds shall be played otherwise decided by the Tournament Committee in consultation with the Chief Arbiter before the commencement of the Championship.

1. **Session:** The rate of play shall be 45 minutes + 30 Second each.
2. **Walk over Time:** The walk over time is only 10 minutes. A player conceding two consecutive walks over shall be removed from the Championship.
3. **Tie Break:** The Tie-Break is as follows: -
 - a) Cut Buchholz 2 lowest cut
 - b) Median Buchholz 1 highest & 1 lowest cut score.
 - c) Buchholz
 - d) SB Point
 - e) The greater number of wins (forfeit included)
4. **Protest:** Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1,000/- within 30 minutes of the occurrence of the incidence. The protest fee will be refunded if the appeal is upheld.
5. **Appeal Committee:**
 - a) Chief Arbiter
 - b) President of AISCD.
 - c) Hony General Secretary of AISCD.
 - d) AISCD Technical Director – Chess.
 - e) Interpreter.
6. **Score Sheets:** Players shall be required to maintain a neat and legible score sheet of the moves, players on the hand over the fair copies of the score sheet to the Chief Arbiter, when recording result of their games. Only the games of which score sheets are available will be considered for the Championship.

7. **Scoring:** The winner of a game shall score one point, the loser zero: both players in a drawn game will score half point each.
8. **Tips:** The final ranking will be decided by individual score and in case of equal scores at the end of the Championship between two or more players the tie shall be broken by applying the following criteria successively in the order given.
 - a) Cut Buchholz (2 lowest cut score of the opponent).
 - b) Median Buchholz (1 highest & 1 lowest cut score of the opponent)
 - c) Buchholz
 - d) SB Point (sum of the won & Drawn games of the opponent)
 - e) The greater number of wins (forfeit included)
9. **Chess Clocks:** The Chief Arbiter shall have the power to introduce clocks at his/her discretion, if he/she so deems necessary, at any time during the game.
10. **Pairing:** The Pairing is done by using "Swiss-Manager official Chess pairing software from FIDE & AICF. Protest against pairing is not allowed.
11. **Request for the late-start, postponement etc:** The playing schedule will be strictly adhered. Any request for late start of a game may be granted only under extreme and unavoidable circumstances and on the basis of a written application by the concerned player to the Chief Arbiter.
12. **Championship Committee:** The Championship Committee shall have the power to interpret the rules and make additions and alterations there to without assigning any reason therefore. The decision of the Championship Committee on all matters relating the Championship shall be final and binding on all players.
13. **Chief Arbiter:** The Chief Arbiter shall be in charge of making the draw, and maintaining disciplines in the Championship Hall. The Authority of the AISCD Technical Director – chess in this matter and the decisions he takes in the discharges of his duties shall be final and binding on all players.
14. **Disqualification:** No participant will leave the venue before the Prize Distribution function without the permission of the Chief Arbiter. The participants disregarding this rule will be suspended for one year.
15. **Interpretation:** For Interpretation of the rule(s) and deciding any point not covered by the above rules of the Championship, the decision of the Championship Committee shall be final and binding on all. The Championship Committee has every right to make any addition or amendment to these rules, without notice. Such changes will, however, be displayed in the Championship Hall.
16. **Age Proof:** Each participant must produce a valid certificate to prove his/her age. Certificates from School are not enough. Certificates should preferably be from the Panchayat, Municipality or Corporation obtained soon after birth. Players without date of birth certificates will not be allowed to participate.
17. The date of birth certificates registered within one year of the birth of the child alone will be recognized and allowed to participate. No State affiliated Unit shall recommend any player who doesn't come under the above criteria. Any player who is aggrieved by this stipulation can appeal to AISCD with proper documentary proof and the AISCD's decision in this regard will be FINAL and BINDING.
18. If any doubt arises about the claimed age of a player, the Championship Committee has the right to refer the player during the Championship for a due evaluation of age by competent medical experts. A player if declared over-age by such experts shall not continue in the Championship

and the matter shall be reported to AICF. Protest about the age of players may be made to the Chief Arbiter in writing along with a fee of Rs. 1000/- per player. This will not be refunded.

19. **No Protest about over age of a player will be entertained after 2nd round of the Championship.** Only the Coach or Manager deputed by participating State Chess Association can lodge such protests. The Championship Committee has the right to decide the day, time and place for such medical evaluation of age. AICF/ Organizers will have the right to refer any player to the medical evaluation of age at any time during the Championship.
20. Players refusing to take the test as decided by the Championship Committee shall be deemed to have failed the test and shall be disqualified from the Championship.

Section – VIII: Entry Fee and Penalty Fine

1. Entry Fee @ Rs. 200.00 (Rupees two hundred only) per senior participant including Coach-cum-Manager and Rs. 100.00 (Rupees one hundred only) per junior participant of State Affiliated Units shall be paid to AISCD, New Delhi through NEFT.
2. Each state must deposit of **Rs.5,000.00 (Rupees five thousand only)** with AISCD towards **Caution Deposit** which will be refunded only within three months if “no damage or disturbance is caused” by the team members during the Championship.
3. Penalty Fine: Double of entry fee shall be paid as non-starting.


Section – IX: Accommodation & Food

1. All the competitors and accompanying Coach-cum-Managers (for the prescribed number only) shall be provided with free boarding & lodging during the Games.
2. No observer shall be allowed.
3. All competitors and managers must bring their own bed sheet / blanket and personal items.
4. The mess will open with the lunch on 05th of January 2025 and will close with the breakfast on 09th of January 2025
5. Teams / Competitors (including accompanying officials) who have lost their match / event and having no more match / item to complete in the Games can leave the camp, if they desire so, with the permission of the Organising Secretary. List of such competitors must be submitted to the Organising Secretary by the Manager / Head of the concerned State team.

Section – X: Prize and Awards

1. In addition to certificate of merit, the 1st six place winners in men group, 1stthree place winners in women group and 1stthree place winners in Junior Boys as well as Junior Girls will receive appropriate cash prizes, subject to availability of funds.
2. Special Prize for Overall Team Championship will be awarded with trophy if sponsorship received. No team Rolling Shield will be presented to the winners.
3. Participation Certificate may be presented by the Hosts to each individual competing in the Championship.
