Sub: - VIII National Deaf Men's T20 Cricket Championship, Kadarpur, Gurugram, Haryana State on April 19 to 25, 2025 – Regarding.

Dear friends,

We are very glad to write to you all that following the decision of the Weekly Meeting of AISCD Technical Directors of Cricket the bidding of the VIII National Deaf Men's T20 Cricket Championship has been allotted to the Haryana Sports Council of the Deaf during April 2025 and the Haryana Sports Council of the Deaf has submitted the Bidding Application to the AISCD. The Said National Championship is fixed to be held at CRB Sports Gound BMR Sports Ground, Vaishno Marg, Kadarpur, Gurugram, Haryana State on April 19 to 25, 2025. **Tentative date details may be seen in the Technical Rules.**

Three (3) matches given below will be played per ground per day. Arrival must be before one hour of the commencement of each match. Late arrival at the Ground will be on penalty fine of Rs. 1,000.00 (Rupees one thousand only).

1. From 07:30 AM to 10:30 AM
2. From 11:00 AM to 02:00 AM
3. From 02:30 PM to 05:30 PM


The last date of **Preliminary Entry Form** for the Said National Championship is **08-03-2025** to enable us to draw the **fixture** on **10-03-2025**. The last date of **Final Entry Form with Names** is **31-03-2025**. Late receipt of the Final Entry Form with Names will be charged to **Rs. 100.00 (Rupees one hundred only) per day**. **Entry Fee** must be remitted to AISCD Account by NEFT **on or before 08-04-2025**.

Please note that the penalty fine for the Withdrawal of Preliminary Entry Form will be charged to **Rs. 10,000.00 (Rupees ten thousand only)** per state team.
