As per the final entry form submitted by the Haryana Sports Council of the Deaf for the National Wrestling Championship of the Deaf 2025, it has been observed that two wrestlers have been entered in the same weight category, which is in violation of the Technical Rules governing the championship – wherein only one (01) wrestler per weight category per state is permitted.

#### Details of Doubles Entries:

- Wrestling Freestyle 79Kg:**
  - Deepak (20-10-1995)
  - Ajay Kumar (20-12-1995)
- Wrestling Freestyle 86 Kg:**
  - Amit (29-04-1999)
  - Rakesh (01-01-1996)
- Wrestling Greco-Roman 77 Kg:**
  - Kuldeep Sharma (01-07-1996)
  - Ajay Kumar (20-12-1995)

It has also been brought to our notice that Mr. Ajay Kumar and Mr. Amit did not participate in the Haryana State Deaf Wrestling Championship held in September 2024. However, both were included in the final entry list upon request, and the reasons submitted have been considered valid:

- Ajay Kumar** – Suspension withdrawn as per AISCD Letter No. AISCD/EBM/2023-2024/004 dated 30-10-2024.
- Amit** – Recognized Wrestling Olympian and Asia Pacific Medallist; absent due to illness.

#### Request and Reallocation:

Mr. Ajay Kumar has formally requested to shift from Freestyle 79 Kg to Freestyle 74 Kg, while retaining his entry in Greco-Roman 77 Kg.

#### Final Decision by AISCD:

To ensure compliance with the Technical Rules and maintain fair selection, AISCD has scheduled official selection matches between the concerned wrestlers from Haryana. These will be held:

  - 2. Ajay Kumar (20-12-1995)


**Important Instructions:**
