"Any athlete whose name is not included in the List of the selected athletes may take part in the selection Trial on 21st and 22nd April 2024" with the following conditions to maintain the sports decorum and performance in accordance with Indian Standard List in our Memorandum - 1 dated 03-04-2024:-

- Entry form to be duly filled and signed by State Association in accordance with the Indian Standard list or Production of Merit Certificate with reading within last 6 months to be mailed latest by 18th April 2024.
- "NO CAMP NO TRIAL" FOR ATHLETES (Both Athletics and Volleyball)
- In case of Youth Athletes writing Board Exam X & XII have to produce Hall ticket with exam date within camp period!
- In case of Volley Ball selection team, whoever cannot attend the camp for any reason will not be selected and not allowed to be replaced at any cost. Still the other players found to be skilled other than the names mentioned in list can attend the selection trial on 22nd April 2024.
- Food and Accommodation to be arranged by Self.

Please note that the Age of the **Youth Athletics**' athlete must be born between 01-01-2005 and 31-12-2008 and Senior Athletics' athlete must be born on or before 31-12-2008 while the Age of the **Senior Volleyball's** athlete must be born on or before 21-06-2010.
