### MEMORANDUM – 1

Sub: - DIBF Asia Pacific Basketball Championships, Melbourne, Australia on September 22 to 29, 2024 – National Selection Trial – Announcement – Regarding

It is a pleasure to inform you all that as per the communication dated 04-04-2024 from the ICSD Associate Member – Deaf International Basketball Federation, the 2024 Asia Pacific Deaf Basketball Championships is scheduled to be held at Melbourne, Australia on September 22 to 29, 2024.

It may be noted that the details for this Championship have not been included in our ACTC Proposal Templates 2024-2025 due to the late receipt of the information from DIBF. After a long discussion with Mr. Balamurugan PG, AISCD Basketball Technical Director, it is decided that the Indian Team will have to bear their own expenses for the National Coaching Camp and Participation to the DIBF Asia Pacific Deaf Basketball Championships, Melbourne, Australia. The TNSCD has their willingness to host the One-Day National Basketball Selection Trial.

The One-Day National Selection Trial is fixed to be held at the Outdoor Basketball Court, Jawaharlal Nehru Indoor Stadium, Periyamet, Chennai, Tamil Nadu on Monday 29<sup>th</sup> of April, 2024 from 08:00AM till the end.

The Entry Fee of Rs. 3,000.00 (Rupees three thousand only) per athlete / player shall be paid to AISCD through Affiliated State Units under their jurisdiction before 25-04-2024 and respective state units are responsible for their participation.


Strictly no parents or personal coach will be allowed inside the Campus during the Selection Trial, failing which strict disciplinary action is liable to be taken against the concerned player like temporary / permanent ban.

Note that those who has not hold his valid passport shall not be allowed to enter in the Trial.
