- 1. The Sports Authority of India has been pleased to approve the participation of 05 Men + 03 Women + 05 Youth Boys + 01 Youth Girls + 01 Head Coach + 02 Assistant Coach + 01 Physiotherapist + 01 Lady Escort at cost to Government and another 03 Men + 01 Women + 01 Youth Girls at no cost to Government as per the Administrative Sanction No: 39 dated 10-06-2024 of the Sports Authority of India, Headquarters, New Delhi which has been received by e-mail only on 11-06-2024 about lunch time.
